**Responsible Personnel:** All research study personnel including investigators and study staff

**Policy Statement:** Industry sponsored Research Protocols will not be released to parties outside DF/HCC without permission of the Sponsor.

**Definitions:**

Industry sponsored Research Protocol- Protocol sponsored by a company (e.g. pharmaceutical or biotechnology) includes the protocol document, investigational drug brochures, clinical research forms and other protocol related documents excluding the informed consent document.

**Procedure:**

- 1) Industry sponsored Research Protocol documents are considered confidential and cannot be released to any individual or party outside of DF/HCC without permission of the sponsor. Examples of parties considered outside of DF/HCC include research subjects (potential or enrolled), patient's family members or friends, third party payers; other healthcare facilities or investigators employed at outside institutions, or media.
- 2) A request for release of the protocol document requires approval in writing by the sponsor. The correspondence must be filed in the DF/HCC Lead Site Regulatory Binder.

- 3) This policy does not apply to the informed consent document or protocol summaries and study worksheets created by the study team, which can be shared with outside parties without permission.
  
- 4) This policy does not apply to federal and state agencies such as The Department of Health and Human Services (DHHS), The Food and Drug Administration (FDA), the National Institutes of Health (NIH), the Office for Human Research Protections (OHRP) or other domestic or foreign government bodies if release of protected information is required by law and/or is necessary for oversight purposes and quality assurance.
